INVITATION FOR BIDS

Sheriff's Office Uniforms

Notice is hereby given that the Commission of Limestone County, Alabama will receive competitive bids on uniforms for the Limestone County Sheriff's Office as per attached specifications.

Bid is effective from February 2, 2026, through February 1, 2027. It is anticipated that the contract will be for a period of one (1) year. Contract may be renewed if agreed by the parties for one-year terms not to exceed three (3) years. The county reserves the right to opt out of renewal and/or terminate the contract if not satisfied with the vendor. Any and all taxes and/or fees must be included in prices. Prices quoted are firm for the life of the contract.

Subsequent to the award of the contract, any merchandise found to be inferior to the samples submitted will not be accepted.

You are invited to bid on the attached specifications. The county reserves the right to accept or reject any or all parts of this bid and to award in whole or part, whichever is in the best interest of the county.

Bids will be opened on **Monday, the 26th day of January 2026**, at **10:00 a.m.** and awarded on **Monday, the 2nd day of February 2026**.

REQUIREMENT: Pursuant to Alabama Code 31-13-9, as a condition of the award of any contract, the business entity or employer, and any of its subcontractors, shall provide a sworn affidavit and documentation that it will not knowingly employ, hire for employment, or continue to employ an unauthorized alien; that it is enrolled in the E-Verify program; and, during the contract period, it will participate in the E-Verify program and will verify every employee that is required to be verified under applicable state and federal laws. During the performance of the contract, the business entity or employer shall participate in the E-Verify program and shall verify every employee that is required to be verified according to the applicable federal rules and regulations.

All samples will be returned at bidder's expense with no financial liability to be incurred by the Limestone County Sheriff's Office for their shipping, loss or damage.

1. Introduction

This Request for Proposals (RFP) is issued in accordance with applicable **Alabama state law, Limestone County purchasing policies, and County Commission requirements** governing competitive procurement. This RFP does not commit Limestone County to award a contract or to pay any costs incurred in the preparation of a proposal. All proposals become the property of Limestone County upon submission.

The Limestone County Sheriff's Office (LCSO) is soliciting sealed proposals from qualified vendors for the supply of law enforcement uniforms. The intent of this Request for Proposals (RFP) is to establish a contract for the purchase of **5.11 Tactical brand uniforms or equivalent** that meet or exceed the specifications outlined herein.

All items must be suitable for daily law enforcement operations and available in **Ranger Green or its equivalent.**

2. Scope of Work

The successful vendor shall furnish new, first-quality uniforms that meet the performance, durability, and professional appearance standards required by the Limestone County Sheriff's Office. Vendors may propose 5.11 Tactical products as listed or submit "equal" products that meet or exceed all listed specifications and features.

3. Required Uniform Items

Vendors proposing items other than 5.11 Tactical must clearly identify the manufacturer and model number and provide detailed specifications demonstrating that the proposed items meet or exceed all listed requirements. LCSO reserves the sole right to determine equivalency.

6. Pricing

All pricing shall be quoted **FOB Limestone County, Alabama**, and must include all costs associated with packaging, handling, and delivery.

Proposals shall include:

- Unit pricing for each item
- Volume or tiered pricing, if available
- Any minimum order requirements
- Estimated delivery timelines
- Length of time pricing will remain firm (minimum 90 days preferred)

Pricing must comply with Limestone County purchasing standards and shall be firm for the contract period unless otherwise approved by the Limestone County Commission.

Proposals shall include:

- Unit pricing for each item
- Volume pricing, if available
- Any minimum order requirements
- Estimated delivery timelines

All pricing shall be firm for the contract period.

7. Vendor Qualifications

Vendors must demonstrate:

- Experience supplying uniforms to law enforcement or public safety agencies
- Ability to provide consistent sizing and color matching
- Reliable delivery and customer service
- Warranty or return policies for defective items

8. Proposal Submission Requirements

Proposals must be submitted in accordance with Limestone County purchasing requirements and shall be received **prior to the stated deadline**. Late proposals will not be considered.

Each proposal must include:

- Company name, physical address, and contact information
- Federal Tax ID or Social Security Number (for vendor registration)
- Proof of business license, if applicable
- Product specifications and manufacturer literature
- Confirmation of Ranger Green availability or equivalent
- Pricing as outlined in Section 6
- Any exceptions or deviations from this RFP clearly identified
- Signed acknowledgment of all RFP terms and conditions

Proposals may be rejected if they fail to comply with County submission requirements.

9. Evaluation Criteria

Proposals will be evaluated by Limestone County based on, but not limited to, the following criteria:

- Compliance with RFP specifications and County purchasing requirements
- Product quality, durability, and suitability for law enforcement use
- Price and overall value to the County
- Vendor experience with governmental or law enforcement agencies
- Delivery capability and past performance

Evaluation results and award recommendations may be presented to the Limestone County Commission for final approval.

10. Terms and Conditions

This RFP and any resulting contract shall be governed by the laws of the State of Alabama and applicable Limestone County policies.

Limestone County reserves the right to:

- Reject any or all proposals
- Waive informalities or minor irregularities
- Request clarification or additional information from any vendor
- Negotiate terms with the selected vendor(s), if permitted by law
- Award all or part of the contract in the best interest of the County
- Cancel, amend, or reissue this RFP at any time prior to award

No proposal shall be accepted or contract awarded without approval of the Limestone County Commission, where required by law or County policy.
